

The Lincoln Parish Police Jury met in special session on Tuesday, February 25, 2020, at 6:00 p.m., at its regular meeting place in the Courthouse, Ruston, Louisiana. Present were: Theresa Wyatt, District One; Hazel Hunter, District Two; T.J. Cranford, District Four; Logan Hunt, District Five; Glenn Scriber, District Six; Matt Pullin, District Seven; Joe Henderson, District Nine; Milton Melton, District Ten; Sharyon Mayfield, District Eleven and Annette Straughter, District Twelve.

ABSENT: Skip Russell, District Eight

President Joe Henderson called the meeting to order. T.J. Cranford delivered the invocation and led the Pledge of Allegiance.

Annette Straughter offered a motion, seconded by Glenn Scriber, to approve the Agenda as presented. The motion was voted upon and carried with the following votes:
