Capacity

- Minimum of 55 tons in 12' length

Dimensions

- Minimum 8'6" width x 53' length
- Deck length: 25' (flat deck design)
- Deck height under full load: 22"
- Deck flooring – apitong – 1-1/2" covering outside only

Gooseneck Design

- Non-ground bearing hydraulic, detachable neck with 9" cylinders, set up for wet line/with Honda Pony Motor.
- 16" King pin setting
- 102" King pin swing radius
- 5/16 King pin plate
- 50" King pin height with 4 available deck height positions 24", 22", 20", 18")
- No Dovetail

Design Deck

- Mainbeams fabricated with 16" I-Beams
- Side rails fabricated with 14" I-Beams
- 10" I-beam crossmembers on 24" centers with 4" stub cross members on 12" centers in outer bays

Bogie Design

- Wheel Well should be covered with wood
- Boom trough – Open "V" Crossmembers
- No rear loading ramp
- Front loading ramp should have a tapered front slope with traction bars
- No landing gear
- D Ring – 16
- 12 Pair of 12" widening brackets (extends deck 2')
- Tool box in front of deck with lockable lid



Axles

- (3) 25,000 lb. capacity w/54 1/2" axle spacings, auto slack
- Plumbed & Trailer brackets mounted for 4th flip only
- Suspension air ride, lift rear axle

Wheels/Tires

- Disc hub piloted
- Tires 275/70R22.5
